

# Why You Need an ADA Transition Plan

- ▶ Reduces risk of future litigation
- ▶ Reduces potential loss of state and federal funding
- ▶ Details methods required to make facilities accessible
- ▶ Minimizes possibility of a settlement agreement with the Department of Justice

## Steps to Compliance

- 1 Designate an employee to oversee Title II compliance (ADA Coordinator)
- 2 Provide notice to the public about the ADA requirements
- 3 Adopt and publish a Title II grievance procedure
- 4 Identify and evaluate current services, policies, practices, and facilities
- 5 Provide an opportunity for public input
- 6 Develop (and maintain) a Transition Plan for needed structural changes, including an implementation schedule
- 7 Monitor the progress on the implementation of the Transition Plan

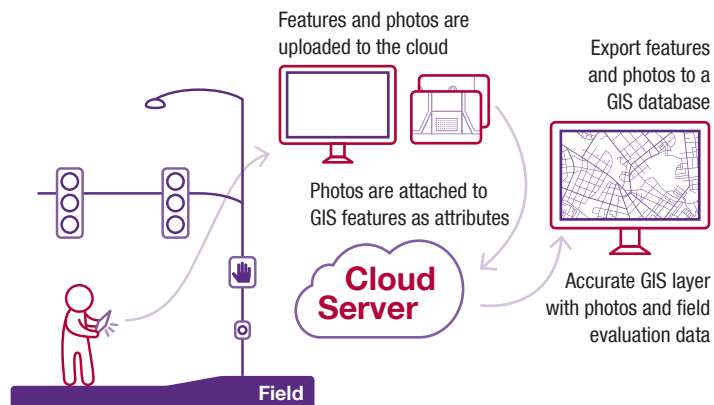

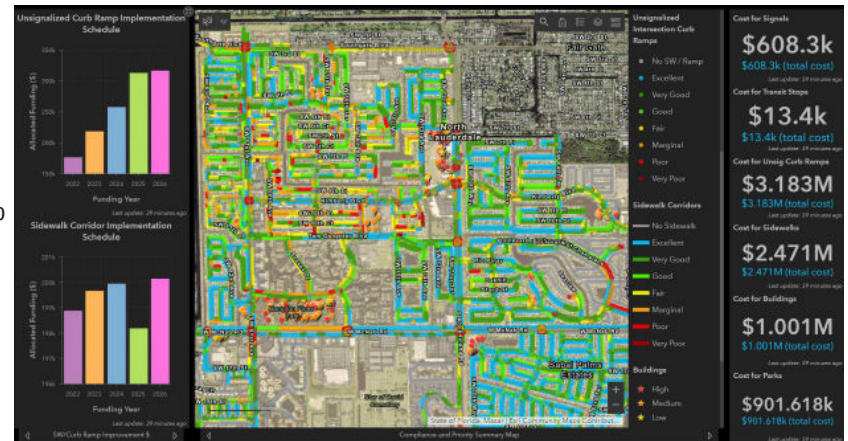
